- *Donald E. Moore v. Dufresne Spencer Group, LLC*, Missouri Division of Workers Compensation, 2023, Successfully obtained permanent and total disability benefits for a 63 year-old laborer.

- *Wallace & Reva Bean v. Orthopedics Associates, et. al.*, Cape Girardeau, Missouri, 2011. Jury verdict on behalf of defendant orthopedic surgeon, alleged to have failed to

recognize a post-surgical complication resulting in an above the knee amputation of the patient.

- *Bonnie Parsell v. Washington University, et. al.*, City of St. Louis, 2010. Jury verdict on behalf of defendant otolaryngologist alleged to have failed to properly treat a cancerous growth.
- *Stephen Nickelson et al v. Wayne Wells, et. al*, St. Louis County, Missouri, 2006. Successful jury verdict in favor of homebuyers against sellers for negligently failing to disclose property defects at the time of sale.
- *Gail Moore v. St. Anthony's Medical Center*, Missouri Division of Workers Compensation, 2019, Successfully obtained permanent and total disability benefits for a 58 year-old nurse
- *Wolfgang Kaschner v. Schlueter Painting, Inc.*, Missouri Labor and Industrial Relations Commission, 2014. On appeal, the Labor and Industrial Relations commission reversed the administrative law judge's decision, awarding permanent total disability benefits to a 59 year-old commercial painter.
- *John Miller v. Chrysler*, Missouri Division of Workers Compensation, 2011. Successfully obtained permanent total disability benefits with multiple work injuries for long-time automotive assembly employee.
- *Gene Tidwell v. Walker Construction*, Missouri Labor and Industrial Relations Commission, 2003. Affirmed on appeal successful defense of workers compensation claim finding injuries were not work related.
